



## **RULES FOR SUBMISSION OF PAPERS**

### **1. The instructions for sending the summary**

- 1.1. The abstract must be sent exclusively through the Even3 platform ([www.even3.com.br/SIMAF](http://www.even3.com.br/SIMAF)) strictly respecting the standard format;
- 1.2. The period for the submission of abstracts will be from 09/01/22 to 10/24/22 at 23:59 (Brasilia time - BRT).

### **2. Rules for submission of abstracts**

- 2.1 Communications of finished and ongoing research of scientific initiation, extension projects, course completion papers (TCC), masters, doctorate and post-doctorate will be accepted. Communications will also be accepted from reports of practical experiences on the proposed topics;
- 2.2 Only one (01) work will be accepted per lead author. The work may contain up to six (06) co-authors;
- 2.3 The identification of the author and co-authors cannot be made in the body of the text, under penalty of disqualification;
- 2.4 Subsequent changes in the abstract text, as well as changes in the names of authors and co-authors, presenters or institutions related to post-submission of the work, will not be possible unless the Scientific Committee requests any revision during the evaluation.

### **3. Themes for the submission of abstracts**

Abstracts will be accepted as a product of research or reports of experience in foster care, which fall within the following thematic axes:

#### **CHILDREN**

This theme aims to discuss questions that are closely related to children in foster care that discusses from preparation for placement in care to family reintegration or adoption, through social work accompaniment. With this, it will be locus of discussions such as: human development; bonding and trauma; babies in foster care; teenagers in foster care; mother and child homes and foster care; methodologies; participation of children and teenagers in their processes; children with disabilities; foster care of indigenous children and those from other minority communities; ethnic-racial relations in foster care, as well as sexuality and gender.

#### **FOSTER FAMILIES**

This theme seeks to deal with research and experiences related to work with foster families in different stages: recruitment, selection, training, retention, arrivals and departures, main challenges experienced in welcoming, etc. Studies and/or experiences that address any other topics related to foster families, such as their links with the children are welcome; relationships between siblings are welcome; and motivations to become a foster family, are also welcome.



#### **PARENTS AND EXTENDED FAMILY**

This theme is concerned with discussing topics that are pertinent to the work developed with families of origin and kinship care. In this sense, it seeks to discuss professional interventions, as well as discussions about parenthood, formal and informal kinship care and other themes that involve the various moments of follow-up in foster care with a view to family reintegration.

#### **FOSTER CARE SERVICE**

This aims to bring together works that address the implementation of foster care services, from the implementation stage and issues related to family care as public policy, to themes of the daily functioning of the services. Sub-themes included in this area are: transition from institutional care to foster family; professionalization of foster families; training of the social work team; methodologies; articulation with the intersectoral network and/or justice system; knowledge and dissemination of foster care; among others.

#### **4. Format for the submissions**

- 4.1. To present a selected abstract during the Symposium, whether for oral presentation or as a poster, it is mandatory for the author(s) to be enrolled in the 4<sup>th</sup> International Symposium on Foster care;
- 4.2. The abstract may be written in Brazilian Portuguese, Spanish or American English, according to the current grammatical and orthographic standards, but the presentation (oral or poster) should be made in Brazilian Portuguese;
- 4.3. Authors of oral communication or posters will need to indicate: full name, institutional affiliation of the author and co-author (if any); the chosen theme. NOTE: the name of the authors may not appear in the body of the text, under penalty of disqualification;
- 4.4. Citations of articles and references in the text must follow the current standards of the Brazilian Association of Technical Standards - ABNT;
- 4.5. The authors and co-authors of the papers are responsible for the content and origin of the material presented, and the Organizing Committee is exempt from liability for non-compliance with ethical, scientific standards or plagiarism.

#### **The structure of the abstract for Oral Communication at the Symposium**

It must contain the following parts as below:

##### **a) Title**

Typed in upper case (capital letters) with a maximum of 15 words

##### **b) Text**

The expanded communication summary should be revised, between 1000 and 1500 words, structured and divided into sections with the titles:

- Introduction
- Objective
- Method
- Results
- Conclusions



NOTE: You will not be allowed to insert figures, charts, and tables. The content of the abstract will not be able to provide information to identify the authors, as it will be a blind assessment.

### **The structure of the abstract for poster presentations at the Symposium**

The poster must contain:

- Title with a maximum of 15 words (centered)
- Full name of the authors, institutions involved, funding institutions, if any, city and state to be filled in the submission platform. The content of the abstract will not be able to provide information to identify the authors, as it will be a blind assessment.
- The communication summary (between 500 and 800 words) must contain:
  - Introduction
  - Objective
  - Method
  - Results
  - Conclusions
- The poster should be self-explanatory and can use illustrations (figures, diagrams and tables)
- The poster must be made on canvas in dimension to be defined after the approval of the works (approximately 0.80m x 1.00m) and its manufacture is the responsibility of the authors.

### **5. Selection**

5.1. A Scientific Committee will be formed that will analyze the proposals submitted in relation to the relevance of the theme to foster care, formal aspects (compliance with standards), scientific and practical experience. This Commission will have full powers to accept or reject the proposals, in whole or in part, with the aim of ensuring the integration of the activities of the 4<sup>th</sup> International Symposium on Foster care and avoiding repetition of themes or participants.

5.2. Regardless of the theme indicated by the author, at the time of submission the work may be reclassified by the Scientific Committee to another theme or modality.

5.3. All qualified abstracts will go through the evaluation and selection process done by the Scientific Committee.

5.4. The Scientific Committee will be responsible for evaluating the work according to the following criteria:

- innovation: whether the work has led to methodological and practical advances through unprecedented results or improvements in available resources;
- application of: the study in the practice of working with families in situations of vulnerability and social risk;
- impact: the size of the work will be assessed for an impact on public policy
- clear relationship with the chosen theme
- compatible theoretical basis
- methodological quality
- following the proposed structure



5.5. The communication of the accepted papers will be made via e-mail to the main author on 09/12/22. All authors selected for presentation will have their registration in the Symposium guaranteed.

#### **6.. General considerations**

- 6.1. The authors, co-authors and supervisors of the abstracts acknowledge and declare, assuming all legal responsibilities, irrevocably, that all the information provided, as well as the content of the work submitted, are true, proper and original;
- 6.2. By submitting the abstract for selection, it is understood that the authors and co-authors authorize the Organizing Committee of the event to publish and disseminate it in all media without any form of payment for copyright;
- 6.3. The papers selected by the Scientific Committee will be published in the Anais of the IV International Symposium on Family Reception (SIMAF);
- 6.4. The Organizing and Scientific Committees are sovereign in their decisions, without the possibility of appeals or manifestations of any kind;
- 6.5. The inclusion of any work, provided that it complied with the rules, implies the unrestricted acceptance of all the rules provided for in these rules
- 6.6. The cases omitted in these standards will be examined by the Scientific Committee.
